- The Executive Committee has been very busy this off season. A Club Manager, Derek McClary, and Office Assistant, Kathy Hill, were hired to fill the positions left by Greg and Joyce. Greg is staying on to aid with the transition into the new season. The Relocation Committee has gathered enough information to proceed with the next steps in moving to the London International Airport. One of the major commitments was to put the London Curling Club on the commercial real estate market. Other reports will likely offer much more detail on this matter.
- One of the new duties of the Past President is to be the liaison for grant applications. This summer Mark Flynn, Head Ice Technician, took an advanced Competitive Curling Course from Curling Canada in Waterloo, Ontario. One of the hardest challenges was finding out how to start the process. I have saved the contact information in the Past President gmail account which should help the process the next time we have to seek education or training course funds. The club should be recovering around \$1,100 dollars.
- One of the projects that I am starting in the fall is an adult learn to curl opportunity for daytime curlers. I have been in contact with Melissa Neeb and she has passed on some good information.
 One of her points was to have qualified instructors. I am taking a coaching course on October 5th at the Highland. Melissa doesn't want people to be confused with the current "Learn to Curl" program. One of the names that I came up with was "Curling Basics". On our website I would propose that we post an advertisement and perhaps elsewhere.
- Curling Basics. This project is designed to attract new adult daytime curlers. Individuals will be taught how to curl based on the individual's ability with a qualified instructor. The cost will be around \$80 dollars for a 'ten-play'. Based on last year's schedule the start times will be 10 am Monday and Tuesday and 12 pm Wednesday and Saturday. The number of participants will be

- Checked on progress with Cimco refrigeration this morning. They are currently waiting on one more piece of equipment to arrive. They are confident they will be done by next week.
- Tuesday tssa is suppose to arrive and inspect the install. Given the go ahead from them Wednesday the insulation crew will arrive to finish up.
- Glycol system was apparently contaminated with oil. I saw the old Glycol it was very dirty and definitely in need of changing.
- On Aug 5- Aug 10th I attended the competition ice technician course (formally called level 3)
- Curling Canada accepted only 25 ice techs from across Canada to attend. I have passed and am now certified as a competition level ice tech. Curling Canada could now call on me to work arena events if they so choose to. The benefits to the LCC is that by attending courses like this I am surrounded by other ice techs with different levels of experiences which enables me to learn different techniques to do installs and everyday tasks. This makes me more efficient and more effective at making the best ice I can.
- Things covered in the course also included rock management, refrigeration plant management, health and safety, and operation techniques.
- At this point our plant start up date is scheduled for Sept 4th. I have built in a bit of room in this year's ice making to allow some time to get to know the new compressor and chiller and allow for any weather we might encounter. We will be good for the start of the season.
